## Subject : Verizon Partner Solutions Industry Letter: Harrison NY ST DMS Switch Retirement

### PLEASE NOTE:

- All references to the Harrison NY DMS switch are associated with CLLI code HRSNNYHNDS0 and will not be repeated throughout this letter.
- All references to the Pleasantville NY CS2k switch are associated with CLLI code PSVLNYPVPSA and will not be repeated throughout this letter.

As set out in the Verizon New York Short Term Public Notice Under Rule 51.333(a), dated December 12, 2025, on or after February 6, 2026, the Harrison NY DMS switch will be retired and removed from the Verizon network as part of ongoing efforts to modernize the network.

**General Information:** The Exchange Codes (NXXs) in Numbering Plan Area (NPA) 914 currently residing in the Harrison NY DMS switch (see list in Table B below) will be moved to the Pleasantville NY CS2k switch (see details in Table A below).

The native NPA NXXs belonging to the Harrison NY DMS switch will be rehomed upon decommissioning of the switch and reflected in the Local Exchange Routing Guide (LERG) for the Pleasantville NY CS2k switch. This will occur on or after February 6, 2026.

### Network Changes and Trunk Rearrangements:

The Pleasantville NY CS2k switch will be the recipient office of traffic migrated from the Harrison NY DMS switch. Traffic

bound for the codes listed in Table B will be delivered via the Whiteplains NY 08T Tandem (WHPLNYWP08T intra-lata SHA / WHPLNYWP08TT inter-lata FG Access SHA).

After all traffic is migrated off the Harrison NY DMS switch, this switch will be retired and removed from the network.

CLECs, IXC, IECs, wireless carriers, and paging carriers will need to secure new trunk groups built to the Pleasantville NY CS2k switch or have existing trunk groups to that switch augmented. Carriers that have direct end office trunk (DEOT) with access connectivity in the Harrison NY DMS switch will be required to reposition the codes to the Pleasantville NY CS2k switch.

All ASRs for the Pleasantville NY CS2k switch must be received no later than December 19, 2025, to provide sufficient time to migrate the traffic described above. All traffic must be moved by February 6, 2026, per LERG.

Please adhere to industry standards using normal procedures that pertain to updates and changes to the LERG for all NXXs subject to the retirement of the Harrison NY DMS switch.
