## **Subject : Verizon Partner Solutions Industry Letter: Cameron VA 5ESS Switch Retirement**

### **PLEASE NOTE:**

- All references to the Cameron VA 5ESS switch are associated with CLLI code ALXNVACNDS0 and will not be repeated throughout this letter.
- All references to the Fairfax VA C20 switch are associated with CLLI code FRFXVAFFPS1 and will not be repeated throughout this letter.

As set out in the Verizon Virginia LLC Short Term Public Notice Under Rule 51.333(a), dated February 4, 2026, on or after March 27, 2026, the Cameron VA 5ESS switch will be retired and removed from the Verizon network.

**General Information:** The Cameron VA 5ESS switch will be replaced by the Fairfax VA C20 switch. See details in Table A.

The Exchange Codes (NXXs) in Numbering Plan Areas (NPAs) 571 and 703 currently residing in the Cameron VA 5ESS switch will be rehomed upon decommissioning of the switch and reflected in the Local Exchange Routing Guide (LERG) on or after March 27, 2026. See details in Table B.

Upon decommissioning of the **Cameron VA 5ESS switch**, the twelve (12) native codes (NPA NXXs) that currently reside in the **Cameron VA 5ESS switch** will reflect the Fairfax VA C20 switch in the LERG.

### **Network Changes and Trunk Rearrangements:**

The Fairfax VA C20 switch will be the recipient office of traffic migrated from the Cameron VA 5ESS switch. Traffic to be migrated to the Fairfax VA C20 switch includes all of the traffic currently handled by the Cameron VA 5ESS switch including,

but not limited to, Inter-LATA access traffic (including Feature Group B and D traffic), and Intra-LATA and local traffic (including CLEC, IEC, wireless and Verizon-sector end-office switched traffic). After all traffic is migrated off of the Cameron VA 5ESS switch, this switch will be retired and removed from the network.

All CLECs, IXCs, IECs, ILEC, wireless carriers and paging carriers will need to provision new trunk groups to support direct end office trunking to the Fairfax VA C20 switch. Carriers with existing trunk groups to this switch will need to augment if necessary.

All ASRs for the Fairfax VA C20 switch must be received no later than March 4, 2026, to provide sufficient time to migrate the traffic described above. All traffic must be moved by March 27, 2026, based on LERG change notification.

Please adhere to industry standards using normal procedures that pertain to updates and changes to the LERG for all NXXs subject to the retirement of the Cameron VA 5ESS switch.
