- All references to the Harrison NY DMS switch are associated with CLLI code HRSNNYHNDS0 and will not be repeated throughout this notice.
- •All references to the Pleasantville NY CS2k switch are associated with CLLI code PSVLNYPVPSA and will not be repeated throughout this notice.

## **Description of the Planned Network Change(s):**

The Verizon Harrison NY DMS switch, located at 7 W. Red Oak Lane, West Harrison, NY 10604, will be retired and removed from the network after all traffic served by this switch is migrated to the Verizon Pleasantville NY CS2k switch, located at 465 Marble Avenue, Pleasantville, NY 10570. All traffic to be migrated includes, but is not limited to, Inter-LATA (ACCESS/FG-B-D/CLEC/IXC), wireless, and paging traffic.

### Description of Reasonably Foreseeable Impact(s) of the Planned Change(s):

Competitive local exchange carriers (CLECs), interexchange carriers (IXCs, IECs), wireless carriers, and paging carriers will need to secure new trunk groups built to the Pleasantville NY CS2k switch or have existing trunk groups to that switch augmented. Carriers that are code holders for access connectivity in the Harrison NY DMS switch will be required to reposition the codes to the Pleasantville NY CS2k switch.

All ASRs for the Pleasantville NY CS2k switch must be received no later than January 5, 2026, to provide sufficient time to migrate the traffic described above. These direct end office trunk (DEOT) interconnections will support traffic migration for the Harrison NY DMS switch prior to its eventual decommissioning. Local Exchange Routing Guide (LERG) change effective dates will be posted prior to decommissioning of the Harrison NY DMS switch (on or after February 6, 2026). This will serve to guide interconnect re-routes of traffic for the ten (10) native codes currently served by the Harrison NY DMS switch to reflect the Pleasantville NY CS2k switch as the new home switch.
