PLEASE NOTE:

- All references to the Norbeck MD 5ESS switch are associated with CLLI code SLSPMDNBDS0 and will not be repeated throughout the notice.
- All references to the Hyattsville MD CS2K switch are associated with CLLI code HYVLMDHYP0 and will not be repeated throughout the notice.

Description of the Planned Network Change(s):

The Verizon Norbeck MD 5ESS switch, located at 3716 Bel Pre Road, Silver Spring, MD 20906, will be retired and removed from the Verizon network after all traffic served by this switch is migrated to the Verizon Hyattsville MD CS2K switch, located at 5500 Baltimore Avenue, Hyattsville, MD 20781. All traffic to be migrated to the Hyattsville MD CS2K switch includes, but is not limited to, Inter-LATA (ACCESS/FG-B-D/CLEC IXC), wireless and paging traffic.

Description of Reasonably Foreseeable Impact(s) of the Planned Change(s):

All carriers including competitive local exchange carriers (CLECs), Interexchange carriers (IXCs, IECs), wireless carriers, and paging carriers will need to provision new trunk groups to support direct end office trunking to the Hyattsville MD CS2K switch or have existing trunk groups to that switch augmented.

All ASRs for the Hyattsville MD CS2K must be received no later than **May 18, 2026**, to provide sufficient time to migrate the traffic described above. Local Exchange Routing Guide (LERG) change effective dates will be posted prior to decommissioning of the Norbeck MD 5ESS switch (**on or after June 29, 2026**). This will serve to guide interconnect re-routes of traffic for the NPA codes currently served by the Norbeck MD 5ESS switch to reflect the Hyattsville MD CS2K as the new home switch. All trunks to the Hyattsville MD CS2K switch must be in place prior to the decommissioning of the Norbeck

MD 5ESS switch.
